5. Pre-bid meeting shall be held at *Social Development Division Office Pyuthan* on 13:00 pm at 2083/02/15BS
6. Sealed of Electronic bids must be submitted to the office of *Social Development Division Office Pyuthan* through web portal [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 on 2083/02/15 BS Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 pm, 2083/02/15BS at the office of office. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of *above mention* which shall be valid for 30 days beyond the validity period of the bid. (i.e 20 days)
8. If the last date of Pre-Bid meeting/purchasing/submission day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders may submit modification or withdrawal prior to the deadline prescribed for submission of bid through e-GP system by using the forms and instructions provided by the system. Once a Bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
10. Bidders must self-declare in written that his/her firm is not blacklisted, if not the bid will be considered non-responsible.
11. Other information not mentioned above is as per Public Procurement Act 2063 and Public Procurement Regulation 2064 with latest amendment.
12. The employer reserves the right to amend and correct at any time, in case of any discrepancies or error in bidding document, tender notice or any other document.
13. *Social Development Division Office Pyuthan* reserves the right to accept or reject any bid and to annul the process and reject all bids at any time prior to contract award what so ever.
